



## Changes in the Race Documentation CAM Race 2026

### Change 1. 7 November 2025

In **"Frequently Asked Questions and Answers, race documentation"**:

At the bottom of page 2 of **"Frequently Asked Questions and Answers, race documentation"**, the sentence The VHF installation ... etc. has been changed to: The maritime transmitting/receiving equipment and the possession of the correct registrations are approved if the form "Test Form Maritime Transmitting/Receiving Equipment CAM Race", as shown below, has been truthfully completed and signed by an authorized person after testing, and submitted at registration.

Note: This change has already been incorporated into the documentation.

### Change 2. 7 November 2025

In **"Frequently Asked Questions and Answers, race documentation"**: At the top, the sentence Rule 14 (NoR): 'Radiocommunication/Electronic aids, incl. test form' has been changed to: Rule 14 (NoR): Radiocommunication/Electronic aids, incl. test form and item 43 of the Equipment Inspection Checklist.

Note: This change has already been incorporated into the documentation.

### Change 3. 7 November 2025

Changes in the Equipment Inspection Checklist:

On page 2, item 43, the text "Presentation of the most recent submission 'Overview of Registrations' from the RDI" has been replaced by: "Presentation of the most recent submission 'Overview of Registrations' from the RDI and the Test Form Maritime Transmitting/Receiving Equipment CAM Race."

On page 2, item 45, the reference to Rule 16.4 (SI) must be corrected to Rule 6.3 (SI).

On page 4, item 43, the text has been changed to:

- By presenting the list 'Overview of Registrations' from the RDI, it can be verified whether the relevant equipment has been correctly registered.
- The form 'Test Form Maritime Transmitting/Receiving Equipment CAM Race' must be fully and truthfully completed and submitted at registration. This concerns items 34, 35, 41, and 42 of the Equipment Inspection Checklist.

### Amendment 4. November 12, 2025

Change in class division, page 5 of the Sailing Instructions:

- IRC and ORC1 and ORC2 start first in Start Group 1;
- ORC3 and DH-ORC in Start Group 2;
- Open Class 1 and Open Class 2 in Start Group 3; and finally
- Open Class 3 and Open Class 4 in Start Group 4.

Start Group 2 has been changed to: ORC3 and DH-ORC.

Note: This amendment has already been incorporated into the documentation.

### Amendment 5. November 12, 2025

Addition to the Sailing Instructions: Rule 16.9 SI: First Aid.

At least one crew member must be familiar with:

- first aid procedures;
- hypothermia;
- drowning;
- resuscitation;
- relevant communication systems.

In addition, one other crew member must hold a valid first aid certificate obtained within the last five years.

#### **Amendment 6. November 12, 2025**

Change in the Equipment Checklist.

The text in the explanation of item 25 on page 4 of the Equipment Checklist has been changed to:

Including First Aid or Oranje Kruis booklet. The first aid kit must be fully stocked, appropriate to the duration of the race, the expected conditions, and the number of crew members. The expiration date must not be exceeded.

#### **Amendment 8. 28 December 2025**

Amendment to Rule 1.7 (NoR) – Rules

As Multihulls are now permitted to enter the 22nd CAM Race, the World Sailing Offshore Special Regulations Extract Category 2 Multihulls, Version 1.15 – 25 November 2025 has been added. For Monohulls, the applicable OSR version has been updated to Version 1.15 – 25 November 2025.

The difference between Version 1.14 and Version 1.15 is the addition of Rule 4.27.1.g in Version 1.15.

As a result of this version update, the race documents have been amended to enable the participation of Multihulls, and there are now two Equipment Inspection Checklists: one for Monohulls and one for Multihulls.

Addition to Rule 20 (NoR) – Insurance

Rule 20.3 has been added.

This amendment and addition have already been incorporated into the documents.

#### **Amendment 9. 9 January 2026**

The explanation of item 11 of the Equipment Inspection Checklist (monohulls) has been amended to: ‘Two permanently installed bilge pumps, operable by hand, one on deck and the other below deck.’
